**Assess <u>standards</u> and specifications** for the design and development of interoperable systems supporting the public service.

CAMSS allows you to you to assess the conformance of your standards and specifications with the <u>EIF</u> or the interoperability requirements set out in the standardisation Regulation 1025/2012.

#### You will get...

CAMSS provides you with a **method** for assessing the interoperability of standards and specifications.

CAMSS produces a **catalogue of assessments** (access) with reports. CAMSS also provides the <u>Core Assessment Vocabulary (CAV)</u> which represents and defines what an "assessment" of "assets" is and how to perform the assessment based on "criteria". It is a **domain-agnostic vocabulary**, meaning that it can be used to assess any type of asset.
