1. INTRODUCTION

1.1. Purpose of this document

The purpose of this document is to provide a description about the release versions of the EIC v1.1.0.

The EIC v1.1.0 is a subset of highly reusable and interoperable solutions from the European Commission (TES) and a PDF document including a short narrative of the ELIS and a link pointing to its repository.

1.2. Release date

This version of the EIC will be released on the 26th of July 2019 in Joinup.

1.3. Description

The European Interoperability Cartography (EIC), as defined in the EC Communication COM(2017) 134 Annex 2 on the European Interoperability Framework as a "repository of interoperability solutions for European public administrations provided by Union institutions and Member States, presented in a common format and complying with specific re-usability and interoperability criteria that can be represented on the EIRA".

EIC v1.0.0 has been released on the 12th of June 2018. It was composed by a subset of the best-in-class reusable and interoperable solutions from the European Commission (TES) and EU Member States (IES). About one year later, version 1.1.0 of the EIC has been released, containing upgrades as regards especially the alignment to the new EIRA v3.0.0. In particular, the content of the release has gone through quite several changes with respect to:

- Migration to the EIRA v3.0.0 with a significant Data Quality Improvement
- Update of the Data Quality, Reusability and Interoperability score of the EIC solutions
- Restructuring of the EIC folder composition
- Inclusion of the ELIS (EIRA Library of interoperability Specifications)
