

1.2. Release date

This version of the CAMSS Assessment of CAdES has been released on the 24th of February 2021 in Joinup.

1.3. Description

CAMSS Assessment of CAdES v1.0.0 was released on the 24th of February 2021. This assessment has been performed following the scenario “EIF” using the CAMSS Tools. The purpose of this scenario is assessing the compliance of a standard or technical specification with the European Interoperability Framework (EIF)¹.
