

A CAMSS Assessment is a solution which corresponds to the output of an assessment of a standard, technical specification or standard developing/setting organisation using the CAMSS Tools. The version of the CAMSS Tools used for the performance of the assessments was v3.1.0.

1.2. Release date

This version of the CAMSS Assessment of ELI has been released on the 23rd of April 2021 in Joinup.

1.3. Description

CAMSS Assessment of ELI v1.0.0 was released on the 23rd of April 2021. This assessment has been performed following the scenario “EIF” using the CAMSS Tools. The purpose of this scenario is assessing the compliance of a standard or technical specification with the European Interoperability Framework (EIF)¹.
