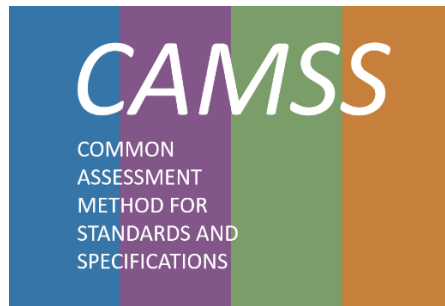

1. INTRODUCTION

1.1. Objective and purpose

This document contains the description of the release version 1.3.0 of CAMSSaaS Solution.

CAMSSaaS (CAMSS as a Service) builds on the MSP streamlined process to provide a User-neutral service whose aim is the assessment of technical specifications and standards on demand through the use of CAMSS Tools. The version of the CAMSS Tools used for the performance of the assessments will be **v4.0.0**.

1.2. Release date

This version of the CAMSSaaS has been released on the 30 of June 2021 in Joinup.

1.3. Description

CAMSSaaS v1.3.0 was released on the 30 of June 2021 to conform both the first service in the ISA² action and the first service based on the use of CAMSS Tools. This service consists on the provision of assessments of technical specifications to the Users on demand. These assessments will be carried out by the CAMSS Team, and for this purpose the CAMSS Tools will be used.
