

1. INTRODUCTION

1.1. Objective

This document contains the description of the release v5.0.1 of the EIRA Library of Interoperability Specifications (ELIS) Solution. This version of the ELIS is aligned with the version v9.2.0 of TOGAF⁶ and v5.0.1 of EIRA⁷.

1.2. Release date

This version of the ELIS has been released in Joinup on the 13th of December 2022.

1.3. Description

The ELIS is a library containing the standards and specifications defining the interoperability requirements of the architectural building blocks (ABBS) contained in the version 5.0.1 of European Interoperability Reference Architecture (EIRA). The aim of this library is supporting solutions architects when modelling using EIRA.
