1 INTRODUCTION

1.1 Purpose of this document

This document contains the description of the release version 1.3.0 of the Semantic Interoperability Maturity Assessment of a Public Service (SIMAPS).

1.2 Release date

Version 1.3.0 of the SIMAPS Survey has been released on the 30th of November 2022 on Joinup.

1.3 Description

The SIMAPS Survey is a highly user-friendly online questionnaire. Designed as a self-assessment tool, the SIMAPS survey is designed for public service owners to evaluate key semantic behavioral interoperability aspects of their digital public service. On completion of the survey, the public service owners receive tailored, confidential feedback and recommendations on how to further improve their digital public service.
