

#### **1.1** Purpose of this document

This document contains the description of the release version 1.0.1 of the VAT scheme for SMEs partial solution.

#### **1.2 Release date**

This version of the VAT scheme for SME v.1.0.1 has been released on the  $14^{\rm th}$  of March 2023 in Joinup.

#### **1.3 Description**

VAT scheme for SMEs v1.0.0 was release on the 7<sup>th</sup> of February 2023 after maintaining several meetings with European Member States and other countries and validating the model.

Some weeks later, version v1.0.1 was released, containing some modifications regarding the Legal view. The release's content has been developed through an agile project management approach. Tickets from EC and Member states/countries were considered to address their feedback and requirements.
