1 INTRODUCTION

1.1 Purpose of this document

This document contains the description of the release version 2.3.0 of the Interoperability Maturity Assessment of a Public Service (IMAPS).

1.2 Release date

Version 2.3.0 of the IMAPS Survey has been released on the 25th of July 2024 on [EU Survey Portal](#).

1.3 Description

The IMAPS Survey is a highly user-friendly online questionnaire. Designed as a self-assessment tool, the IMAPS survey is designed for public service owners to evaluate **key behavioural interoperability** aspects of their digital public service. On completion of the survey, the public service owners receive tailored, confidential feedback and recommendations on how to further improve their service.
