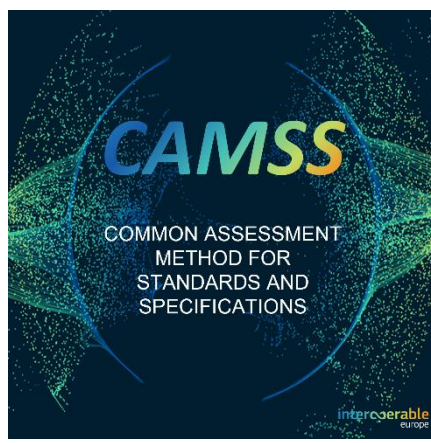

This version of the CAMSS Assessment Data Privacy Vocabulary (DPV) 1.0 has been released on the 31th of October 2024 in Joinup.
