New vision: Federated repositories through Linked Open Data



New connections and ideas in the the field of **Linked Open Data** have sparked increased interest in **federated repositories**.

A promising approach discussed most vividly in the past months is to use techniques from the field of Linked Open Data in order to realise a federated **search across platforms**.

Ever since the first concept for the SEMIC.EU platform the vision of such a federation of semantic repositories has been with us. As new ideas are brought to the fore and repositories are built, concrete steps are now being taken to turn the vision into reality.

New community

SEMIC.EU is currently setting up a new community of experts to drive the topic further.

agroXML agroXML is a systematic definition of agricultural data structures using XML-Schemas and content lists.

AT Marital Status This list of terms describes the marital status of a physical person.


XML structures for personal data This XML structure shall be used in Austrian eGovernment applications to structure personal data.




Do you **use, own or know of** registries or repositories that might be candidates for federated searches e.g. through SEMIC.EU?

Linked Data: esd standards



With its "Projects Ontology" **SEMIC.EU's new partner esd** ("electronic service delivery") aims to make **data on projects and case studies** publicly accessible.

The project will define a standard template and **RDF ontology** for sharing details of projects and case studies as Linked Data, implement an application to input, share and display projects, and disseminate the approach and get others to adopt it in a Linked Data network of project repositories.

An initiative of British local governments, esd standards features controlled lists suitable for populating **metadata associated with local government resources**. Each local government list is supported through the esd-toolkit and its online forum.
