- PM Introduces the meeting's agenda and points out the importance of using the wiki to support the Task Force discussion
- PM asks if there are any comments on the minutes of the last Work Group meeting
 - With no comments the meeting minutes is adopted.

3. Brief overview of the Process and Methodology for Core Vocabularies and how to make contributions

Discussion -

- SG <u>presents</u> the motivation of the Core Vocabularies initiative
- SG presents the definition of Core Vocabularies
- SG presents the main process that has been followed to develop the Core Vocabularies
- SG briefly presents the main steps of the methodology to be followed by the working group.
- PM asks about the experience of the steering group on the endorsement of similar work and related adoption of a specification.
 - VP explains that the ISA committee consists of representatives of MS. The endorsement decision will be taken by representatives of central government units.
 - PM enquires about the participation of agencies directly involved in the implementation of e-Govenment specifications in the ISA committee.
 - VP explains that the involvement varies according to the MS of origin. The ISA Programme has the mandate to make an endorsement decision. However endorsement it does not guarantee implementation.
 - CT explains that even standards have no guaranteed implementation. There are many examples on standards which have never been adopted. Adoption depends on the extent to which the standard actually solves a problem.

4. Contributed use cases

Discussion -

 AW presents the Case Study on the European Banking Authority and the main attributes to identify Financial Institutions. <u>https://webgate.ec.europa.eu/CITnet/confluence/display/ISACV/FINANCIAL+INS</u> <u>TITUTION+REGISTER+%28European+Banking+Authority%29</u>



- SG explains that the TF should abstract the information from use cases to build the Core Business Vocabulary.
- SG highlights the requirement for an identifier and the relationships between banking entities (and their branches) as an important characteristic that could be abstracted from this use case
 - AW explains the challenges in defining a unique identifier.
- CT asks about for a legal definition of a bank
 - AW explains that the definition varies according to MS.
 - CT suggests the definition of a Bank as an institution with a license or permission of a public authority to carry out banking activities in a particular jurisdiction.
 - CT gives examples on the possible activities and events that can happen to a Bank over time.
 - CT suggests that Banking is an example where a specific public agency gives permission to exercise some activity; e.i. a legal entity to perform an activity
 - SG summarises CT's proposal as "a bank can be conceived to be a legal entity allowed to perform activities by a certain public agency."
 - o CT suggests that "LegalEntity isLincensed forActivity"
- SS Comments on the MS interoperability framework.
- SS suggests that e-Codex people should be involved also on the Core Business Task Force

5. Conceptual Model

Discussion -

ISACV-129 Business - How is a Business different from a (natural) Person?

- SG reminds the WG of the previous discussion between a natural person representing a business which does not have a separate legal entity. He also mentions that most use cases seem to point in the direction of considering a business to be a legal entity which carries out business activities.
- CT comments that there is a difference between a legal entity and a person performing business activities.
- SG proposes that the scope of the Core Business Vocabulary scope should restricted to legal entity
 - The majority of the group agree with the proposal. Proposal accepted.

ISACV-125 How is a Business different from an Organisation?



- CT explains that a legal entity is an organisation. Organisations can be a group of people. A legal entity is a type of organisation which has been authorised to exercise activities. A legal entity is a subset of an organisation.
 - VP explains that there are formal and informal organizations.
 Formal=legal, informal = non-legal. Not all formal organizations are businesses. There are several types of formal organizations including NGOs, public, profit, non-profit, PPP
 - $\circ~$ TV comments that this definition can be linked to the legal concept of each MS
- SS question the objective of the specification model.
- SS explains that there is a difference from a abstracting attributes from use cases and building a model for data transfer.
- SS suggest to model ID for use in Person, Business and Location
 - SG suggests that the task force should only focus on the Core Business Vocabulary.
- Due to lack of time PM suggests to close the meeting and postpone the remaining discussion to the next meeting
 - The majority of the participants agree with the proposal
- PM confirms if the participants are available to participate on the next 2 schedule meetings on 15 and 22 December.
 - Mostly of the participants are available to participate on the next 2 schedule meetings.
