## **DECISIONS AND ACTIONS**

- What is Core?

The working group agreed to retain concept of membership so that one organisation can be shown to be a member of another. PA to check that the ORG ontology's use of the Membership class reflects this (and suggest an alternative if not). It was decided not to extend to people and roles played.

- COFOG as SKOS

 The working group agreed that it is important to retain classification and purpose as mandatory properties but not to require use of COFOG specifically.
- org:purpose, classification, cpsv:type

- Change Event Class
