Ref2Link – What is it?

- ✓ Ref2Link is a text-mining software component designed to **detect and value legal references or citations** detected in unstructured texts.
- ✓ Developed initially in 2015 as an in-house tool for the Legal Service of the European Commission, Ref2Link has joined the **ISA²** program in 2018 (Action “Legislation Interoperability Tools” - LegIT 2016.38).



Main features

- ✓ Uses flexible and declarative, **detection rules**, which can be designed or tuned for **various domains**
- ✓ Supports **multiple targets** on the same reference
- ✓ Supports **multiple environments** allowing the use of context-dependent sets of rules
- ✓ Supports complex patterns, such as **lists and/or subparts**
- ✓ Returns the **same text enriched with links or a table of detected references**, grouped together when identical





Main detection features

- ✓ Out-of-the-box:
 - EU law and case law in all official languages
 - ECHR case law
 - Permanent Court of Arbitration disputes
 - WTO legal texts and disputes, GATT provisions
 - Antitrust, State aid and Merger cases dealt with by the European Commission
 - EU institutions administrative references covering the decision-making process
- ✓ Supports EU standards **ELI**, **ECLI** and CELEX ids
- ✓ Configurable for national law domains





Enforcing EU Law standards


- ✓ [ELI \(European Legislation Identifier\)](#)
 - ✓ A method for organising and classifying legal information across EU Member States so that it can be easily and durably searched, exchanged or reused.
- ✓ [ECLI \(European Case Law Identifier\)](#)
 - ✓ A method to facilitate the correct and unequivocal citation of judgements from European and National courts.
- ✓ **Based on three pillars**
 - ✓ [Identifiers](#)
 - ✓ [Metadata](#)
 - ✓ [Semantics](#)



ELI features

- ✓ Detect citations acts/treaties, incl. Lists & subdivisions

- ✓ Web applications filled with legal references:
 - ✓ Add hyperlinks to unstructured text sections
 - ✓ Automation for contributors in Web Content Management Systems
 - ✓ Delegate hyperlinks building logic for any data
- ✓ Legislative drafting systems: automation of references structuration e.g. links, footnotes
- ✓ Text analytics: through references extraction
- ✓ Format validation, Quality control
- ✓ User self-service (**LinkPad**)
 - ✓ Build your own hyperlinks
 - ✓ Quick reference-based access to legal resources

Benefit: productivity

For:

- ✓ **Business users**: enjoy direct links that would not exist otherwise
 - ✓ Silo-breaking effect
- ✓ **Web contributors**: spare the time-consuming process of manually creating static links that might become broken
 - ✓ No more need to 'insert link' like this one:

Benefit: sustainability

- ✓ Supports/benefits from European standards:
 - ✓ European Law Identifier (**ELI**)
 - ✓ European Case Law Identifier (**ECLI**)
- ✓ When Links are generated on-the-fly:
 - ✓ A simple display effect
 - ✓ No modification of original web pages & data
 - ✓ Sticks to evolutions in URLs building logics: limits broken links



Benefit: quality & interoperability

Use of Ref2Link fosters:

- ✓ Proper encoding of references & citations
- ✓ Use of links which subsequently avoid duplication of content
- ✓ System suppliers to deliver a consistent and stable URIs policy or at least 'how-to-link' guidelines..





Current limitations

- ✓ Matched patterns have to be self-sufficient for web links construction
- ✓ References need to be clean of formatting elements
- ✓ Aliases & nicknames
- ✓ Orphan subdivisions
- ✓ Generated links do not guarantee:
 - ✓ Availability of the target IT system
 - ✓ Existence of the resource with matched reference
 - ✓ Access rights to the resource
 - ✓ Direct access to the required level of granularity





Ref2Link – Where is it?

- ✓ **IT building block**: enhance existing IT business systems or web sites with the same detection features. It comes with a full API available for client or backend **integration**.
- ✓ Frontend app **LinkPad** on Testa: end users can generate their own hyperlinks or experience quick access to legal references.





Ref2Link – Upcoming developments

- ✓ **Use of Linked Data:** add some meta-data to hits and exploit semantic links to improve user experience.
- ✓ **Batch tool:** for integration in processing chains, test automation..
- ✓ **Multilingual support:** in addition to multilingual mode: language specific distributions to improve speed and accuracy.
- ✓ **Continuous support of standards:** e.g. deeper ELI subdivisions, national implementations ECLI & ELI.
- ✓ **Integration projects**
- ✓ **New backend, EU Login**
- ✓ **Aliases, Nicknames**
