#### **MINUTES**

# 1. Opening

MD presented the purpose of the work on the new implementation guidelines for DCAT-AP:

- Follow up on the discussion points identified during the DCAT-AP workshop organised in May 2016.
- Collecting new change requests for the DCAT-AP (if any) via interactions with implementers through the DCAT-AP community channels;
- Update existing DCAT-AP guidelines to incorporate feedback; and
- Create a number of new practical guidelines that will support the Member States to implement DCAT-AP, focusing especially on the organisational and legal levels;

The purpose of the webinar is to

- Verify with the group that the issues listed are relevant for guidelines
- Discuss possible further development of DCAT-AP
- Look at the wider issues that could/should be on the agenda of SDSVoc
- Plan the work ahead, especially in gathering legal and organisational issues

The issues will not be discussed in detail during this meeting. Detailed discussions can take place via:

# 2. Issues for additional guidelines

BW introduced the following issues for which new guidelines could be developed. These issues can be further discussed via the mailing list, or via the links to Joinup provided below.

WvG agreed that it is a good idea to create a guideline for this. He explained that the dereferencing MDR controlled vocabularies at the concept level will be supported by the end of the year. BvN mentioned that the issue of dereferencing does not only apply to controlled vocabularies, but also to catalogues and datasets.

AM shared his concern that requiring local administrations to comply with a requirement on how to manage entity IDs might not be perceived well. MD explained that it is not the purpose to impose any additional requirements, but that we could share information on how other public administrations are dealing with this issue. If we identify any of these services, we will list them and distribute them with the working group.

PR proposes to use the PROV-O vocabulary, but agreed with MD that this might be too heavy for DCAT-AP as was already discussed during the development of the profile. The Publications Office of the EU proposes the Roles NAL, which could be extended if needed.

• Partitioning large DCAT-AP metadata files (in case of bulk harvesting) The working group agreed that this issue is not really relevant, hence it will not be considered for a new guideline. BvN added that in some circumstances, it might even be better to have a single file describing all data sets rather than breaking it up in smaller files. AM explained that the problem is not so much with the file, but rather with the use of APIs.

# 3. Issues for revising DCAT-AP

MD introduced an issue that would require an update of DCAT-AP: modelling data quality.

The working group agreed that the modeling of data quality is a relevant issue. Several ideas were proposed, such as referring to standards, using the W3C Data Quality Vocabulary (DQV), etc. The working group will closely follow what happens at W3C, as their solution could be implemented in a future version of DCAT-AP.

AM explained that in his view, the W3C DQV solution is the best available solution on the web. He proposed to share his proposal for implementing data quality in DCAT-AP IT (https://dati.lombardia.it/api/dcat.rdf).

# 4. Issues that require liaison with others

An issue that requires liaison with others is the mapping of DCAT-AP to and from existing dataset publication platforms, e.g. CKAN, OpenDataSoft, Socrata and DKAN. MD asked whether the working group is willing to contribute to identifying solutions and liaising with others. Several ideas were shared via the chatbox:

- PR mentioned an extension for DCAT in CKAN and a tool to publish RDF DCAT-AP metadata to CKAN;
- SK mentioned an extension for importing INSPIRE metadata, viewing it and exporting it as geoDCAT-AP;
- AZ mentioned that the EU ODP has experience with CKAN and they have a module for ingesting metadata in RDF into CKAN;
- NL informed the working group that native support for DCAT-AP in CKAN is undergoing;
- OA mentioned a GIT project for exporting CKAN to DCAT-AP (National Road Authority in Norway);
- ES mentioned that the developers of DKAN are interested to support DCAT-AP;
- BvN mentioned that Tenforce has open source solutions;
- UV mentioned that Fraunhofer FOKUS might be able to provide more input regarding CKAN.

#### 5. Issues for SDSVoc

MD introduced the issues that could be presented at SDSVoc, as they would require modifications to DCAT:

- Relationships between Datasets, incl. versioning, time sequence, parent/child and grouping of collections: use of relation types
- Rights and licences for datasets: relationship with licences on catalogue and distributions
- Agent roles: additional set of properties linking to agents
- Service-based data access: modelling of non-file distributions and set of properties to enable machine-processing
- Relationship between Distributions: similarity criteria
- · Packaging of distribution files: expression of format of included files
- Scientific data and data citation
