- The EC Open Source report identified:
 - No structured proposals/policies for Open Source
 - No strategic plan to enable local players
 - No coordination between institutions
 - No coordinated commercial ecosystem
 - Open Source associations: LiLux
 - Negative results when Open Source solutions have been proposed in Parliament.

Loi RDI

Majoration 15 points de pourcentage,
si une des conditions suivantes est remplie:

- le projet ou programme repose sur une collaboration effective:
 - entre des entreprises parmi lesquelles figure au moins une PME, ou est mené dans au moins deux États membres, ou dans un État membre et une partie contractante à l'accord sur l'Espace Économique Européen, et aucune entreprise unique ne supporte seule plus de 70 pour cent des coûts admissibles, ou
 - entre une entreprise et un ou plusieurs organismes de recherche et de diffusion des connaissances, et ce ou ces derniers supportent au moins 10 pour cent des coûts admissibles et ont le droit de publier les résultats de leurs propres recherches;
- les résultats du projet ou programme sont largement diffusés au moyen de conférences, de publications, de dépôts en libre accès ou de logiciels gratuits ou libres.

Establishment of a data cloud as a GDPR-compliant platform for teachers in Luxembourg

The Centre de gestion informatique de l'éducation, the IT resource management administration of the Ministry of National Education, Children and Youth in Luxembourg, is in charge of preparing and implementing the government's policy in the areas of education, children and youth. In 2020, the CGIE launched a Nextcloud service to provide **about 15000 teachers and staff members** with a GDPR compliant file storage.





 - **asynchronous information**




Assessment:

- Luxembourg participates as an indirect partner to the IPCEI-CIS
- Creates Open Source SOC and CERT technology for the Cloud
- Creates an **open cybersecurity Data space**
- **Publishes all via a “resource centre”, which will be transformed into an OSPO in cyber security**
