This version of the B2B intra-community transactions e-invoicing reporting v.1.1 has been released on the 17.06.2024.

## 1.3 Description

B2B intra-community transactions e-invoicing reporting v1.0 was released on the 17<sup>th</sup> of April 2024 after maintaining several meetings with European Member States and other countries and validating the model.

Version v1.1 has been released, containing some modifications with the comments received from the working group as feedback. Comments from EC and Member states/countries were considered to address their feedback and requirements.
